





#### **Fig 2: Compliance Category Statistics**



## **1 FINANCE AND TAXATION UPDATES**

There were 144 regulatory updates in this category

- The Reserve Bank of India (RBI) issued a notification regarding statements on Developmental and Regulatory Policies measures relating to Regulations and Payment Systems.
- The Central Board of Indirect Taxes and Customs (CBIC) issues the Draft Bill of Entry (Post Import Amendment) Regulations, 2024. The Bill talks about the process of application and applicable conditions and restrictions.
- The Reserve Bank of India (RBI) issued the Draft Directions on Aadhar Enabled Payment System Due Diligence of AePS Touchpoint Operators. The comments or feedback on the Draft Directions are to be sent before August 31, 2024.
- The NPCI Bharat BillPay Limited (NBBL) issued a circular regarding the expansion of the Scope for Cross Border Transactions on BBPS.
- The Goods and Services Tax network (GSTN) issued the notification regarding the Advisory for Biometric-Based Aadhar Authentication and Document Verification for GST Registration Applicants of Jammu & Kashmir and West Bengal.
- The Ministry of Finance (MoF) issued a notification declaring August 13, 2024 as the date on which the amendments to the Prevention of Money Laundering Act, 2002 shall come into force.
- The Government of India on August 09, 2024 issued the Banking Laws "Amendment" Bill, 2024.



- The Bureau of Indian Standards (BIS) issued the date of establishment and withdrawal of the Steel Plate for Pressure Vessel for Intermediate and High Temperature Service including Boilers.
- The Ministry of Consumer Affairs, Food & Public Distribution (MoCAFPD) issued the Consumer Protection (Salary, allowances and conditions of service of President and Members of the State Commission and District Commission (Amendment) Model Rules, 2024 to further amend the Consumer Protection (Salary, allowances and conditions of service of President and Members of the State Commission and District Commission (Amendment) Model Rules, 2024.

There were 339 regulatory updates in this category

- The Ministry of Information and Broadcasting (MIB) issued the notification regarding Provisioning of satellite capacity on Non-Indian Satellites. The deadline for the existing arrangements for Provisioning of capacity by Non-Indian Satellite Operators is March 31, 2025.
- The Indian Banks' Association (IBA) issued the notification regarding the Dearness Allowance for Workmen and Officer Employees in banks for the months of August, September, October, 2024.
- The Telecom Regulatory Authority of India (TRAI) issued the Standards of Quality of Service of Access (Wireline and Wireless) and Broadband (Wireline and Wireless) Service Regulations, 2024. The same shall come into force on October 01, 2024.
- The National Payment Corporation of India (NPCI) notified regarding the enablement of UPI mandate feature of Single

Block Multiple Debts. It states that the ingle Block Multiple Debts mandate shall only be applicable to the P2M category of transactions.






