





Fig 2: Compliance Category Statistics

FINANCE AND TAXATION UPDATES

There were 249 regulatory updates in this category

- The Reserve Bank of India (RBI) notified regarding the update in Master Direction Other Remittance Facilities.
- The Reserve Bank of India (RBI) issued an update on the Master Directions on Reporting under Foreign Exchange Management Act, 1999.
- The International Financial Services Centres Authority (IFSCA) notified regarding the incentive provided by IFSCA for filing of ESG Funds by registered FMEs at GIFT IFSC.
- The Reserve Bank of India (RBI) issued the Directions Compounding of Contraventions under FEMA, 1999.
- The Goods and Services Network (GSTN) issued an advisory regarding the GSTN e-Services App to replace the e-Invoice QR Code Verifier App Shortly.
- On October 8, 2024, the Ministry of Finance issued a notification announcing amendments to Notification No. 1/2017 -Central Tax (Rate), originally dated June 28, 2017. This amendment pertains to the Central Goods and Services Tax (CGST) rate schedule.
- On October 7, 2024, the Goods and Services Tax (GST) E-Waybill System released a notification providing guidance on the accurate entry of RR No./Parcel Way Bill (PWB) numbers, following the integration of the E-Way Bill (EWB) system with the Parcel Management System (PMS).
- On October 9, 2024, the Reserve Bank of India (RBI) issued its Monetary Policy Statement for 2024-25 following the Monetary Policy Committee (MPC) meeting held from October 7 to 9, 2024. The MPC decided to keep the policy repo rate under the liquidity adjustment facility (LAF) unchanged at 6.50%, with the standing deposit facility (SDF) rate at 6.25% and the marginal standing facility (MSF) rate and Bank Rate at 6.75%. The committee also shifted its monetary policy stance to focus on maintaining inflation within the medium-term target of 4%, within a 2% range, while continuing to support economic growth.
- The Reserve Bank of India (RBI) on October 4, 2024, issued the notification regarding the Due diligence in relation to non-resident guarantees availed by person's resident in India.



- The Income Tax Department on October 9, 2024, notified following classes of taxpayers must file their return on or before October 31, 2024.
- The Ministry of Finance (MoF) on October 8, 2024, issued a notification regarding the number of HSN digits required on tax invoice Union Territory Tax Rate.
- The Central Board of Direct Taxes (CBDT) notified on October 17, 2024, regarding the extension of the due date to file the audit report in the correct Form 10B/10BB as applicable for A.Y. 2023-24 to November 10, 2024, from March 31, 2024, via notification no. Order u/s 119 dated October 07, 2024, for those taxpayers who filed Form 10B/10BB till October 31, 2023, but filed Form 10B instead of Form 10BB and vice versa.
- The Central Board of Indirect Taxes and Customs (CBIC) on October 16, 2024, notified regarding the implementation of

the Agreement signed between FSSAI, the Ministry of Health and Family Welfare, the Government of India, and the Bhutan Food and Drug Authority (BFDA).

- The Ministry of Finance (MoF), on October 15, 2024, issued the Income-tax Amendment (Eighth Amendment) Rules, 2024, to further amend the Income Tax Rules, 1962.





6 LABOUR UPDATES

There were 89 regulatory updates in this category

- The Pension Fund Regulatory Development Authority (PFRDA) issued updates regarding Master Circular Guidelines on Know Your Customer / Anti-Money Laundering / Combating the Financing of Terrorism (KYC/AML/CFT).
- The Board of Practical Training (BOPT) notified regarding the invitation to Enhance Apprenticeship Engagement.
- The Labour Department, Government of NCT Delhi issued a notification regarding the revision of minimum wages for categories of workers in the scheduled employment.
- The Ministry of Corporate Affairs (MCA) on October 3, 2024, issued the guidelines for the Prime Minister's Internship Scheme which targets providing 1.25 lakh internship opportunities for FY 2024-25 in top companies identified based on the average CSR expenditure of the last three years.
- The Government of Karnataka on September 29, 202, issued the notification regarding permitting all Shops and Commercial Establishments in the State employing ten or more persons to be open on 24*7.
- The Labour Department of the Gujarat Government issued the minimum rate of wages under the Contract Labour (Regulation and Abolition) Act, 1970. It provides the rates of Minimum Wages to be paid to labourers effective from April 24, 2023 for skilled, semi-skilled and unskilled workers. It also provides the rate of special allowance for October 1, 2024, to March 31, 2025 for workers employed in any manufacturing company, shops and establishment and contractors.
- The Government of Goa on August 29, 2024, issued the scheme to provide financial assistance to registered organizations/government organizations/Institutions for running homes for senior citizens suffering from chronic and debilitating diseases including diseases like Alzheimer, Parkinson etc. and those in palliative care.
- The Ministry of Social Justice and Empowerment (MoSJE) on February 14, 2024, issued the notification regarding the Policy regarding "Equal Opportunities policy for Transgender Persons". The primary objective of this comprehensive policy is to create an atmosphere that ensures the fair treatment of transgender individuals.

General aspect of ESI Scheme, benefits provided under ESI Scheme, Formation of State Autonomous Body/Society by States, Medical Benefits Provided Under ESI Scheme and Recovery of Contribution and Details of Prosecution Cases have been stated.
