



Fig 2: Compliance Category Statistics



### 1 FINANCE AND TAXATION UPDATES

There were 135 regulatory updates in this category

- The Income Tax Department on November 07, 2024, notified regarding the availability of Form 3CEDA and Form 3C-O for Filing on the E-Filing Portal.
- The Reserve Bank of India (RBI) on November 07, 2024, issued a notification regarding the 'Fully Accessible Route' for Investment by Non-residents in Government Securities Inclusion of Sovereign Green Bonds. On the issuance calendar for marketable dated securities for October 2024 to March 2025, has announced that Sovereign Green Bonds with a 10-year tenor issued in the second half of FY 2024-25 will be designated as "specified securities" under the Fully Accessible Route (FAR).
- The Goods and Services Tax Network (GSTN) on November 05, 2024, issued the advisory for Form GST DRC-03A. It states that a new Form GST DRC-03A has been developed on the GST portal to adjust the paid amount through DRC-03 against the corresponding demand order.
- The Central Board of Indirect Taxes & Customs (CBIC) on November 01, 2024, issued the Guidelines for Customs field formations in maintaining ease of doing business while engaging in investigation into tax evasion cases in import or export.
- The Government of Odisha on October 21, 2024, issued a notification regarding the number of HSN digits required on tax invoice.


