The month saw 1,056 legal and regulatory changes across Centre and States and across various categories.





Fig 2: Compliance Category Statistics



1 FINANCE AND TAXATION UPDATES

There were 175 regulatory updates in this category

- The Ministry of Finance (MoF) on February 28, 2025, issued an amendment Notification under the CustoThe Central Board of Indirect Taxes and Customs (CBIC) on March 04, 2025, issued the notification regarding the Disposal of Unmanned Aircraft Systems (UAS)/Unmanned Aerial Vehicles (UAV)/Remotely Piloted Aircraft Systems (RPAS)/Drones.

- The Union Cabinet on March 19, 2025, approved an incentive scheme aimed at promoting low-value BHIM-UPI transactions (Person to Merchant P2M) for the financial year 2024-25. The scheme, with an estimated outlay of Rs. 1,500 crores, will be implemented from April 1, 2024, to March 31, 2025. It focuses on incentivizing UPI transactions up to 2,000 for small merchants at a rate of 0.15% per transaction.
- The Ministry of Finance (MoF) on March 18, 2025, issued the Customs (Administration of Rules of Origin under Trade Agreements) Amendment Rules, 2025 to further amend the Customs (Administration of Rules of Origin under Trade Agreements) Rules, 2020.
- The Ministry of Finance, (MoF) on March 18, 2025, issued a notification stating initiatives to Strengthen Cyber Security in Financial Transactions.
- The Reserve Bank of India (RBI) on March 17, 2025, updated the Master Direction Export of Goods and Services.
