



Fig 2: Compliance Category Statistics




1 FINANCE AND TAXATION UPDATES

There were 362 regulatory updates in this category

- The Ministry of Fisheries, Animal Husbandry & Dairying (MoFAH&D) on September 04, 2025, notified regarding the GST relief across the Fisheries Value Chain: Fishing Nets, Seafood Products, and Aquaculture Inputs all at 5%.
- The Ministry of Textiles (MoT), on September 04, 2025, notified regarding the Next-Generation GST Reforms Boosts India's Textiles sector.
- The Reserve Bank of India (RBI) on September 04, 2025, issued a notification regarding a change in Public Holiday and Market Operations.
- The Ministry of Heavy Industries (MoHI) on September 04, 2025, issued a notification regarding GST Rate Cuts for Automobiles and Transport Sector.
- The Ministry of Finance (MoF) on September 01, 2025, issued the Income-tax (Twenty-Fifth Amendment) Rules, 2025, further to amend the Income-tax Rules, 1962.
- The Ministry of Food Processing Industries (MoFPI) on September 08, 2025, issued the notification regarding the Simplification of GST Rates: Boosting Processed Food Industry, Investment, and Employment.
- The Central Board of Indirect Taxes and Customs (CBIC) on September 10, 2025, issued a notification regarding Service Downtime.
- The Directorate General of Trade Remedies (DGTR) on September 08, 2025, issued a notification regarding an Antidumping investigation into imports of "Glass Fibre" originating in or exported from Bahrain, China PR, and Thailand.
- The National Payments Corporation of India (NPCI) has issued new guidelines to clarify the rules and liabilities for NETC transactions involving FASTags that are hotlisted, blacklisted, or have a low balance. These rules, which became effective on February 17, 2025, are designed to enhance efficiency and reduce fraud at toll plazas. A key change is the introduction of a new reason code (176) for declined transactions.
- The Reserve Bank of India (RBI) on September 10, 2025, notified regarding the Launch of the Microsite for Banknotes.
- The Central Board of Indirect Taxes & Customs (CBIC) on September 17, 2025, issued a notification regarding categories of registered persons ineligible for provisional refund under the CGST Act
- The Ministry of Finance (MoF) on September 18, 2025, issued amendments to the Hindi Version of the Notification No. 10/2025- Central Tax (Rate), published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R. 660 (E), dated September 17, 2025, related to the GST exemption on essential goods
- The Income Tax, Department on September 18, 2025, notified regarding the Offline Utility for ITR-7 for AY 2025-26 is available for filing
- The Reserve Bank of India (RBI) on September 17, 2025, issued FAQs on the Inter-operable Regulatory Sandbox (IoRS)
- The Reserve Bank of India (RBI) on September 15, 2025, issued the Reserve Bank of India (Regulation of Payment Aggregators) Directions, 2025.

- The Directorate General of Trade Remedies (DGTR) on September 23, 2025, issued a notification regardingan Antidumping investigation concerning imports of "Mono ethylene Glycol" originating in or exported from the State of Kuwait, the Kingdom of Saudi Arabia, and the Republic of Singapore.
- The Central Board of Indirect Taxes (CBIC) on September 22, 2025, issued the notification regarding the GST Reforms to Strengthen Hospitality, Transport and Cultural Sectors.
- The Goods and Services Tax Network (GSTN) on September 25, 2025, issued an advisory to file pending returns before the expiry of three years.
- The Income Tax Department on September 24, 2025, issued the Taxpayers' Guide to Claim Exemptions and Deductions.
- The Ministry of Health and Family Welfare, on September 24, 2025, issued a notification regarding the Next-Gen GST reforms in relation to medical devices & equipment.
- The Reserve Bank of India (RBI) on September 24, 2025, renewed its Statement of Commitment to the FX Global Code.



This revision is in line with SEBI's master circular dated August 4, 2023, and modifies a previous MCXCCL circular from March 5, 2025.
- The Bombay Stock Exchange (BSE), on September 05, 2025, notified regarding the SLBS Revision in the settlement schedule for 09th and September 10, 2025.
- The Clearing Corporation of India Ltd (CCIL), on August 05, 2025, notified regarding the declaration of September 05, 2025 as a Business Day for all the Segments and public holiday on September 08, 2025 under the Negotiable Instruments Act, 1881 Postponement of Settlement due on 08th September 2025 to September 09, 2025.
- The National Stock Exchange (NSE) on September 05, 2025, notified regarding the Segregation and Monitoring of Collateral at Client Level-New Portal (Reminder).
- The Bombay Stock Exchange (BSE) on September 4, 2025, issued a notice clarifying the trading and settlement schedule for mutual funds on its BSE STAR MF Platform. This clarification follows the Maharashtra government's decision to shift the Eid-e-Milad public holiday from September 5, 2025, to September 8, 2025, a change subsequently announced by the Reserve Bank of India (RBI).
- The Multi-Commodity Exchange of India Limited (MCX), on September 12, 2025, issued a circular regarding the modification in the Delivery Settlement schedule in Commodity Futures Contracts for Metals.
- The Central Depository Services (India) Limited (CDSL) on September 11, 2025, issued a notification regarding rescheduling of NISM Series VI Depository Operations (CPE) Programme.
- The Central Registry of Securitisation Asset Reconstruction and Security Interest of India (CERSAI) on September 11, 2025, issued a notification regarding Service Downtime.



- The National Pharmaceutical Pricing Authority (NPPA) on September 08, 2025, fixed the retail price of the Empagliflozin 25 mg + Sitagliptin Phosphate Monohydrate IP Equivalent to Sitagliptin 100 mg + Metformin Hydrochloride (As Extended Release) IP 1000 mg for M/s. Exemed Pharmaceuticals (Manufacturer) & M/s. Alembic Pharmaceuticals Ltd. (Marketer).
- The Ministry of Corporate Affairs (MCA) on September 04, 2025, issued the Companies (Compromises, Arrangements and Amalgamations) Amendment Rules, 2025, to further amend the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016.
- The Bombay Stock Exchange (BSE) on September 18, 2025, issued a notice regarding the Release of BOLT Pro TWS Version 12.11
- The Central Depository Services (India) Limited (CDSL), on September 18, 2025, issued a circular regarding the facility for payment of stamp duty by beneficial owners (BOS) through a valid UPI handle

- The Ministry of Corporate Affairs (MCA) on September 17, 2025, has invited public comments on a proposal to establish and promote large Indian Multi-Disciplinary Partnership (MDP) firms. This initiative is part of the government's commitment to enabling Indian firms to grow and compete with international players both domestically and globally
- The National E-Governance Services Ltd. (NeSL) on September 12, 2025, issued a circular regarding SHCIL e-Stamping System Downtime.
- The Bombay Stock Exchange (BSE), on September 25, 2025, issued an circular regarding the Conversion factor for converting from USD to GBP, EURO, and YEN.
- The Ministry of Corporate Affairs (MCA) on September 17, 2025, invited public comments on the establishment of Indian Multi-Disciplinary Partnership (MDP) firms by the Government of India.




