


1 FINANCE AND TAXATION UPDATES

There were 136 regulatory updates in this category

- The Central Board of Indirect Taxes & Customs (CBIC), on February 05, 2026, issued an older notification no. No.36/2001-Customs (N.T.), dated the 3rd August, 2001, published in the Gazette of India, Extraordinary, Part-II, Section-3, Sub-section (ii), vide number S. O. 748 (E), dated the 3rd August, 2001, related to Crude Palm, Gold and Silver.

- The Reserve Bank of India (RBI), on February 03, 2026, issued directions to all Agency Banks pursuant to a request received from the Government of India to ensure timely accounting of government receipts and payments for the Financial Year 2025-26.
- The Lok Sabha on February 01, 2026, introduced the Finance Bill, 2026. The Finance Bill, 2026, is issued to give effect to the financial proposals of the Central Government for the financial year 2026-2027.
- The Reserve Bank of India (RBI), on February 11, 2026, notified the redemption price for premature redemption of Sovereign Gold Bond (SGB) 2018-19 Series-VI, originally issued on February 12, 2019, under Government of India Notification F.No.4(22)-B(W&M)/2018 dated October 08, 2018. In terms of the Scheme, premature redemption is permitted after the fifth year from the date of issue, on an interest payment date. Accordingly, the next eligible date for premature redemption of this tranche falls on February 12, 2026.
- The National Financial Reporting Authority (NFRA), on December 16, 2025, notified regarding the Maintenance, archival and submission of Audit File to National Financial Reporting Authority.


